Subject: Allotment of Equity Shares pursuant to conversion of Foreign Currency Convertible Bonds ("FCCBs") - Tranche - 20

We would like to inform you that the Finance Committee of the Board of Directors of our Company has approved the issue and allotment of an aggregate of **22,21,406** Equity Shares of Rs. 10/- each to the investor/s who have exercised their right to convert FCCBs of US\$ 1,225,000 held by them into Equity Shares. The Equity Shares have been issued and allotted at a premium of Rs. 14.49 per Equity Share (i.e., at a Issue Price of Rs.24.49 per share) in accordance with the terms of the FCCB Issue. Previously the conversion price was Rs. 24.96 per share according the terms of the issue, it got adjusted to Rs. 24.49 per share after the rights issue of shares of the Company in January 2007. **The deemed date of allotment of the Equity Shares is December 28, 2007.**

It may not be out of place to mention that out of the total FCCBs of US\$ 125 million issued by the Company in June 2004, FCCBs aggregating US\$ **109.594 million** have so far been converted into **19,65,71,752** equity shares (including this 20th Tranche) of the Company.

Tata Group holding stands marginally reduced to **65.77%** as a consequence of the above-referred allotment.
