**Subject:** Allotment of Equity Shares pursuant to conversion of Foreign Currency Convertible Bonds ("FCCBs") - Tranche - 5

Pursuant to Clause 22 of Listing Agreement, we would like to inform you that the Finance Committee of the Board of Directors of our Company has approved the issue and allotment of an aggregate of 2,60,65,963 Equity Shares of Rs. 10/- each to various investors who have exercised their right to convert FCCBs of US\$ 14,650,000 held by them into Equity Shares. The Equity Shares have been issued and allotted at a premium of Rs. 14.96 per Equity Share (i.e., at a Issue Price of Rs.24.96 per share) in accordance with the terms of the FCCB Issue. The deemed date of allotment of the Equity Shares is **March 18, 2005**.

It may not be out of place to mention that out of the total FCCBs of USD 125 million issued by the Company in June 2004, FCCBs aggregating USD 46.96 million have so far been converted into 8,35,53,417 equity shares (including 5<sup>th</sup> Tranche) of the Company at a premium of Rs.14.96 per share.

Tata Group holding stands marginally reduced to 66.77% as a consequence of the above-referred allotment.
